

**DRIVING CONSENT, WAIVER, RELEASE FROM LIABILITY,  
and HOLD HARMLESS AGREEMENT**

Do hereby give my consent for my child to drive to and from any school sponsored athletic or extracurricular practice, game, activities, and events when required to do so by the school sponsor or coach. Students will be required to ride the team bus as required by the coach or sponsor.

I, individually and on behalf of my child, do hereby release, relinquish, waive, and agree to forgo any claim or cause of action, known, or unknown, now or hereafter arising, and hold harmless the Waverly Community Unit School District #6, from and against any claim for injury, including death, or loss or damage to my personal property that may be sustained or caused by my child while driving to and from any school sponsored athletic or extracurricular practices or activities when required and directed by the school sponsor or coach.

I, individually and on behalf of the child, do hereby release, relinquish, waive, and agree to forgo any claim or cause of action, known or unknown, now and hereafter arising, against the District, its administrators, employees, board members, or agents for any personal injury to the child or property damage arising from or in any way related to the transportation of the child by other individuals while driving to and from any school sponsored athletic or extracurricular practices or activities when required or directed by the school sponsor or coach. This Consent and Waiver shall be binding upon me, my child and our heirs, successors and assigns.

This release extends to any and all claims I have or may have, and any and all claims my child has or may have, against the District, even if such claims result from negligence on the part of any or all of District employees or administrators, concerning supervision, directions, weather conditions, or vehicle condition, or from any other cause.

I hereby state and represent that:

- ❖ My child is experienced in and familiar with the operation of the vehicle(s) he or she will operate for transportation to and from school sponsored practices or events;
- ❖ My child holds a current, valid Illinois Driver's License;
- ❖ I certify that the vehicle(s) my child uses for transportation to and from school sponsored practices or events is properly registered with the Illinois Secretary of State and is currently licensed or operation on the roadways of the State of Illinois.
- ❖ My child and the vehicle used for this transportation are fully insured by a qualified Vehicle Insurance Company and at the rates currently required under the *Illinois Vehicle Code*.
- ❖ I fully understand the risks and dangers inherent in my child driving to and from school sponsored practices or events; and
- ❖ I expressly agree to assume the entire risk of personal injury, including death, which my child and minor passengers might suffer as a result of his or her participation in driving to and from school sponsored practices or events.
